

MIFID II product governance / Professional investors and eligible counterparties only target market

– Solely for the purposes of each manufacturer's product approval process, the target market assessment in respect of the Notes has led to the conclusion that: (i) the target market for the Notes is eligible counterparties and professional clients only, each as defined in Directive 2014/65/EU (as amended, "**MiFID II**"); and (ii) all channels for distribution of the Notes to eligible counterparties and professional clients are appropriate. Use of Proceeds

The proceeds of the Notes form part of the funding of the Issuer for its general corporate purposes and, will not be committed to or earmarked for lending to, financing of, any specific loans, projects or programs.

Through its general corporate activities, the Issuer intends to contribute up to USD 7,000,000,000 in financing to counter the impact of the coronavirus pandemic which includes USD 5,000,000,000 in long term investments and USD 2,000,000,000 in trade finance operations. The Issuer intends to focus on companies impacted by the crisis, directing funding to health and health-related sectors, as well as access to short-term lending for small and medium-sized enterprises through financial institutions, supply chain and trade finance.

The Issuer has neither established a separate framework for application of the proceeds of the Notes nor will be reporting on the impact of the use of proceeds of the Notes or conducting any external review of such impact or use of proceeds. Each potential investor should make its own assessment of the suitability of the intended use of proceeds with respect to its own investment criteria.
