The IIC will require the Fund Manager to undertake an environmental review of each of the investee companies, including their compliance with national environmental, safety and labor laws and regulations and IIC's environmental and labor guidelines. The Fund Manager will also be instructed not to participate in category IV projects without prior IIC clearance, to provide the IIC with an annual environmental report, and to develop corrective action plans for proposed investments, if necessary.
